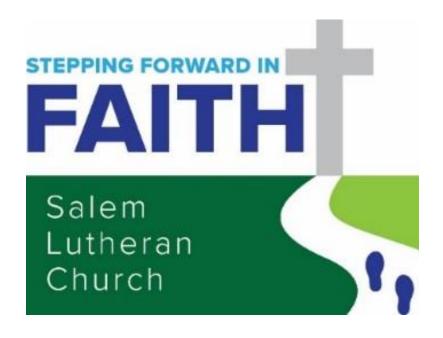

#### **PASTOR'S REPORT**

The first thing I want to say is, "Thank You!" Thank you for your generosity serving our Lord, sharing your time, talents and treasure in ministry here. It is truly remarkable what you do every day! Welcome Team sends a list of activities to visitors and new members to give them ministries where they might participate. Listen to just a partial list of what you are doing:

There's the choir, bells, and praise band. Folks can volunteer at Salem West and/or Mustard Seed. There are dinner and a movie nights the 3<sup>rd</sup> Tues. of the month, quilting with the Piecemakers and knitting with In Stitches on Tuesdays, Men's Bible study on Fridays, Women's Bible study on Wednesdays and Coffee Klatch Bible study at Heartwood the 4<sup>th</sup> Friday at 1pm. Folks can help lead worship at Crosby Nursing Home or help deliver Meals on Wheels.

Kid's Club meets Wednesdays during the school year, as do confirmation classes. During Lent there's Wed. worship & lunch at noon, Wed. supper and worship at 5:30, and 1st Communion classes on Sundays.

Salem offers dynamite VBS in June, and prepares 100 sack lunches every Friday during the summer for Lunch Bunch. There's a Camp-out near Walker in June, a Men's Fishing Retreat at Lake Kabetogama in July, Bible camp for youth and families all summer, and a Women's Bay Lake Retreat in October.

The whole community's invited to Summerfest in August (which you work on all year long), Trunks for Treats in October, a Community Thanksgiving Dinner in November and an Advent Dinner in December, not to mention Volunteer Appreciation Dinners in May & Oct.

You do all that in addition to wedding and funeral ministries, maintaining the building and property, welcoming visitors and new members, supporting a missionary in Liberia, a camp in Honduras, a meal center in Brainerd, a Habitat for Humanity build in Deerwood and so much more.

It is remarkable what you do every day. Thank you!

2019 has been a year of transition. In the last 16 months or so Salem lost well over 50 years of institutional memory and experience as staff members moved on to new chapters in their lives. But new people have stepped in and are doing excellent work, Kennedy with the choir, Tammy in the office, Chanda as financial manager, Mark & Debbi as custodians, Don as director of outreach, Steve and Erica at Salem West, and Julie, Bev, and Joey at Mustard Seed. Be sure to thank them for their work!

Special thanks to Faith Formation for stepping up to continue Sunday school, Kid's Club, and other ministries in the absence of staff leadership. VBS was the big one. One month before VBS they found out that VLM had to cancel all Day Camps due to lack of employees. The volunteers flew into action, pulled it all together and did a magnificent job.

Over 30 years ago Salem adopted a mission statement:

We exist to:

Welcome people to Jesus Christ,

Equip people with a faith that works in their lives, and

Send people into the world in Jesus' name.

Our mission statement helps us to remember why we're here. It helps us keep the main thing the main thing!

Two years ago Salem adopted a 5 Year Action Plan:

"In addition to maintaining ministries and programs that are working well, Salem members identified 4 areas of ministries they felt God calling us to concentrate on in the next 5 years. (Evangelism, Youth & Family, Adult Faith Formation, Stewardship) In response to our changing world Salem's council, committees, and individuals, are encouraged to engage in faith-filled experiments, to try at least 2 new ministry ideas per year."

In the last 2 years there have been many faith-filled experiments in ministry! There's a new Kid's Club, a Grief Group, speakers for the organ. We swapped preachers for Lent and summer creation care. Groups created letters for new arrivals in town and pew cards welcoming parents and small children. We tried going to 1 worship service, took confirmands to camp and synod gatherings, advertised at Back to School Night, and had one of our youth (Jasmine Siliznoff) elected to the NE-MN Synod Lutheran Youth Organization (LYO).

Not all experiments are successful, of course, but we learn from all of them. Thank you for sharing your energy and creativity! I look forward to another year of innovative faith-filled experiments in ministry!

In all of the work we do together, we rest in the promises of our Lord to make it prosper. Jesus said in John 15: "I am the vine, you are the branches. The one who abides in me and I in them, he it is that bears much fruit, for apart from me you can do nothing... You did not choose me, but I chose you and appointed you that you should go and bear fruit and that your fruit should abide; so that whatever you ask the Father in my name, he may give it to you."

Father, bless these your people here at Salem. Bless their efforts and the ministries in this place. Let them prosper and be all to your service and your glory. In Jesus' name. Amen.

#### Salem's 5 Year Action Plan

In addition to maintaining ministries and programs that are working well, Salem members identified 4 areas of ministry they felt God calling us to concentrate on in the next 5 years. In response to our changing world Salem's council, teams, committees, and individuals are encouraged to engage in faithfilled experiments, to try at least 2 new ministry ideas per year from the list below or from their own ideas.

**Evangelism**: How do we "Welcome people to Jesus?" Some ideas include:

- Reach out to the neighborhood with faith
  - o Pray for the unchurched and events outside our walls during worship
  - During worship, 2 times per year, train all Salem members to welcome and engage newcomers
  - Create at least 2 outdoor public worship services per year.
  - Sponsor events to which the entire community is invited such as open gym nights at the Auditorium, etc.

- Create "Rock the House" worship experiences
- Reach out to those who've fallen away
  - Make contact with members who've been absent 4 consecutive weeks
- Reach out to the next generation
  - Sponsor at least 4 inter-generational faith events per year
  - o Nurture mentor relationships in FINK, Sunday school, etc.
  - Create an "Every Kid Goes To Camp" culture, and full camperships to make it possible
- Reach out to New Members
  - Create and distribute welcome gifts to 1<sup>st</sup> and 2<sup>nd</sup> time visitors
  - o Enlist and train "befrienders" who will journey with new members for 1 year
  - Quickly incorporate new members into small groups, studies, and activities that fit their interests and abilities
- Study other churches to learn best practices

**Youth & Family Ministry** – How do we **Welcome** and **Equip** Youth in new and compelling ways. Some ideas include:

- Mountain bike ministry
  - Bike clinic & blessings
  - Intergenerational rides
  - Multiple church events
  - Extra bikes for those who don't have a bike
- Mini Series that appeal to youth
- Create Youth friendly culture and worship
  - Empower and train youth to lead all parts of worship
  - Incorporate smart phones and social media into communications, study and worship
- Reach out to Young adults
  - o Monthly Beer & Hymns or Wine & Word events at a local establishment
  - Coffee shop
  - Create online worship opportunities
  - o Create a Salem App for smart phones
- Reach out to Families
  - Create a small group for Moms
  - Use the popularity of, and information from, VBS to draw families
  - o Encourage and promote "Faith 5" family devotion time
  - Create a Pre-school
  - Experiment with new ways to equip busy families with a faith that works in their 24/7

**Adult Faith Formation** – How do we **Equip people with a faith** that encourages personal and corporate growth and knowledge of Jesus? Some ideas include:

- Create a congregation wide small group series for Lent or another season
- Create 2 new confidential focused prayer groups
- Create monthly Adult Sunday School/Forums with guest speakers/presenters
- Enlist 4 Salem members per year to attend Lay School of Theology
- Promote/initiate/develop in-home Bible study/small groups

**Stewardship** – How do we **Equip people** with a generous faith and **Send people** to serve God with everything they have? Some ideas include:

- Offer an annual "Financial Peace University" style course
- Enlist Salem members to tell "Why I give" faith stories during offering time quarterly or monthly
- Teach about money without asking for any at least 2 times per year using the principles: 1) It all belongs to God, 2) I am a steward, 3) How I live with money is a faith issue
- Create a menu of ways to give that are convenient for 21<sup>st</sup> century Christians such as credit/debit card kiosks or online apps for electronic giving
- Develop planned gift education programs

Thirty four women attended the 2019 Annual Women's Retreat October 11-13 on Church Island, Bay Lake. Joining the Salem women were 17 women from First Lutheran Church in St. Paul. #### **FAITH FORMATION TEAM**

In the absence of a Children's Ministry Coordinator, the Faith Formation Team has planned and carried out faith formation activities with volunteers.

Prayer Buddies – adult members pray for children in the congregation. We currently have 12 Prayer Buddies praying for twelve children.

Vacation Bible School in June was a success because so many volunteers stepped forward when VLM was not able to come. Plans are being made to have VLM lead Vacation Bible School this year.

VLM Camps – Dee Dee Frahm and Kris Schmidt are our delegates this year. More information on Camp Sunday and registration will be coming soon.

Trunks for Treats was very popular this year with over 200 participants. We had businesses join us in providing treats. Thank you to all who helped.

Kids Club continues to be our largest regular activity with approximately 18 kids each time. Volunteers plan and supervise learning activities, Bible lessons, snacks, games and outdoor time for children in our congregation and community.

Sunday school is available during worship so that children can attend church with their families and get a lesson based on the "one room school" combining all ages.

Four students were confirmed last spring. We have six young adults participating this year and three new families are represented.

Six students and adult chaperones went bowling and shared pizza last spring. Another bowling night is being planned for this year.

Kids Bible Sunday is coming up on February 9th for 4th, 5th, and 6th graders who have not yet received Bibles.

A Ski Trip is in the planning stage for this winter.

A Youth Works Mission Trip is being organized for this summer.

Confirmation students will be meeting with Faith Mentors during Lent.

We really appreciate the volunteers who make these opportunities happen. Thank you so much for sharing your time and talents.

#### **SALEM LED SIGN UPDATE**

The LED sign committee has been working thru 2019 on possible designs, locations and pricing. We have worked with Albrecht Sign Company from Fridley Minnesota. They have given us some designs that would incorporate our existing Salem granite sign. There pricing came in over our budget and also would have include some Salem volunteer labor.

With that and the fact that we would need another company's input on possible designs, locations and pricing. We are presently working with Ross Louis Sign Company out of Bemidji Minnesota with their proposal. (This is the company that built and installed the LED sign for Bethlehem Lutheran Church, which is located on hwy. 210, by Cub.)

Our committee goal is to have this phase completed by spring so that our new LED sign can be installed this coming summer.

#### **LIBRARY TEAM**

The Salem Library looks out into the Memorial Garden and has a cozy fireplace with chairs for reading and relaxing. In addition to over 2000 books, there are videos, DVDs, CDs, audio books, and games available for check out.

We have a great variety of reading material in the library – something for everyone's reading tastes: Bibles, Biographies, Devotionals, Christian Life, Fiction, Church History, Young Adult, Children's Books, Music, Movies, and Games.

A collection of Outreach Resources deal with sensitive topics – grief, addiction, mental health, cancer, etc. These are on a shelf labeled Outreach Resources to the left of the fireplace. To respect privacy, these resources do not need to be signed out. There is not a time limit. They may be taken out when needed and returned.

Checking out library materials: Your library check out is an honor system. After you select a book, video, DVD, CD, or game, please write your first and last name on the card from the pocket on the item to be checked out. Stamp or write the date due on the card and date due slip. Please leave the card in the file on the desk. You may keep a book for up to 4 weeks and other materials for one week. Please place your returns in the basket so the cards can be put back and the items put away in their correct location.

The Salem Library continues to be blessed with gifts, donations, and memorials. There is a selection policy to help with the purchase of new items and weeding of old. We accept suggestions and donations to buy new books. We will also look over books that you may want to give away and decide if they are

appropriate for the Salem Library. If we have duplicates or do not need them, they are donated to other libraries, the Little Free Libraries, the jail ministry, or the Mustard Seed.

#### **WELCOME TEAM**

Pastor Mike invited us to begin a "Welcome Team" in 2018 to be active in welcoming people interested in joining Salem Lutheran, help them through the process, and making the event significant. We also were charged to plan events for our congregation that would be social, getting people acquainted.

In 2019, we became an "official" committee by the Salem Church Council that would be added to the church budget. To date, we have assisted in welcoming 15 new members. We give "new members" a gift bag upon joining, plan a reception with cake & coffee the day they join, present them with a boutonniere, and take their pictures to be shared on the bulletin board near Fellowship Hall. We also prepare gift bags that are on Welcome Table for visitors to our services.

  activities in our church. We have contacted the Cuyuna Range Chamber & CI Courier for assistance in
  new residents as well
- Prepared and laminated letters to parents of small children to know we accept and rejoice having children in our midst, not to worry, and placed letter in pews.
- Had a "Song & Suds" Event at the Cuyuna Brewery inviting members, friends & neighbors to play
   Trivia, sing and share stories. A second social event is being planned for this spring.

Opening Prayer was led by Pastor Mike.

#### **Approval of Minutes:**

- A motion to approve the minutes from the Council meeting on October 17, 2019, was seconded.
- Motion carried.

#### Treasurer's Report:

• Council had lengthy discussion regarding the proposed 2020 Budget. Motion to accept proposed budget for presentation to the congregation for final approval was seconded. Motion carried.

#### Pastor's Report:

- On November 3<sup>rd</sup>, 2019, 13 people in 5 households who had joined Salem were publicly recognized.
- Kid's Club is up and running and is having a great turnout.
- 2020 Estimate of Giving Cards were returned on Consecration Sunday with 79 estimates of giving plus 25 units using Simply Giving. Last year there were 116 estimates of giving plus Simply Giving.
- The 2019 Nominating Committee has found candidates for all the open positions. Some positions have only as many candidates as openings.

#### **Unfinished Business**

- Mark Carlson is working with the Bank to obtain the renewal of the parking lot agreement.
- Update from the Security Team. They met with Midwest Security and liked what they heard. The team will be meeting to discuss the next steps.
